ANTI RAGGING COMMITTEE

According to the provisions and rules made by the government to stop ragging and following it, the college administration is committed to stop ragging of the students admitted to the college and not to create a conducive environment for ragging. The students are closely monitored from the effect of the session itself. If found indulging in ragging, students are advised to avoid such illegal acts by giving information about the legal provisions against the culprits.

- Information about ragging (Government Rules) is also displayed in college website.
- The anti-ragging committee also work closely with monitoring of code of conduct committee and discipline committee and organizes various awareness lecture for students related to the matter.

Hence, it is noteworthy that due to the continuous efforts of the college administration and the Anti-Ragging Committee, not a single case of ragging has been found in the college from the session 2016-17 to 2020-21.
