In the academic session 2016-17, students complained about college related problems before the grievance redressal cell. Which was decided by the Grievance Redressal Cell, the details of which are as follows –

- Trilok Singh B.Com first year NCC cadets got the attention of the college drinking water inconvenience, cleanliness of water cooler and bathroom on 10.09.2016. In 11.09.2016, Grievance Redressal Cell Committee has organized the necessary meeting and ordered to solve the problem, to provide adequate drinking water facility and to clean the sweepers.
- Devendra Kumar Markande B.Com 1st year complained about the water drainage near the
 college campus, sports ground and water cooler on 14.11.2016. Grievance Redressal Cell
 proposed to connect the NSS students to the cleanliness of the college premises under regular
 activities.
- P.G. in the college on 05.12.2016 by the student union. Application was given to conduct the classes of Mathematics, Biology and M.COM. In view of the problems of the students, the committee organized a meeting on 06.12.2016 and apprised the Principal and Correspondence was made to the Commissioner of Higher Education and Chhattisgarh Government through proper channel to conduct PG classes in the respective subjects. As a result, PG classes of M.COM and Political Science started in the session 2020 -21.
- Saraswati Devangan B.Sc. final year student complained about fan shutdown in girl's common room and classrooms on 07.02.2017. The scavengers were ordered by the Grievance about getting the fan made.
